Saws and Slaws is organized exclusively for charitable purposes. The purpose of this community organization is to promote, organize and conduct mountain neighborhood fire mitigation events.







Thank you for your interest in hosting a Saws & Slaws event.
Included here are some responsibilities and costs associated with hosting an event.

Step 1: Site Review

To do effective fire mitigation that is beneficial to the health of the forest, we require a professional site review by a licensed forester. The costs of which are paid directly to the service provider by the homeowner. As part of the review, the forester will become familiar with the specific site and with the homeowners' identified priorities. The forester will then mark the trees that need to be removed.

Step 3: Homeowner Costs for Hosting an Event

Insurance & Chipping

To help cover insurance, chipping, and other costs, homeowners will be asked to pay according to the below table, which includes up to four hours of chipping by one or two chippers associated with each event.

Step 2: High Risk Felling (optional)

Saws & Slaws volunteers will not fell any high-risk trees. This includes trees near power lines or structures.

Homeowners can have the high-risk trees felled by a professional before the event. The professional can then leave the boles (trunks) and slash for the Saws & Slaws volunteers to clean up and remove during the event. It reduces the expense for the homeowner by reducing the work the professional would typically do.

The high-risk felling could be done any time after the event as well.
